1 Environmental Policy Statement

3P recognises that it has a responsibility to the environment beyond legal and regulatory requirements. We are committed to reducing our environmental impact and continually improving our environmental performance as part of our business strategy and operating methods, with regular review points. We will encourage customers, suppliers and other interested parties to do the same.

2 Scope

This environmental policy covers all activities at 3P which represent the whole product lifecycle (from bid to aftersales).

3P's biggest contributor to negative environmental impacts stems from the manufacture of machinery. However upstream from this, as a custom equipment manufacturer, the ongoing design of the machinery and customer requirements set in stone a number of environmental impacts on a machine-by-machine basis.

Interested parties are defined in 3P's Business manual and are reviewed on an ongoing basis as part of the quality manual review.



3 3P's environmental commitments

- Continually improve our management systems to enhance environmental performance and implement best practices into our process areas
- Reduce our consumption of resources and generation of waste, both in our business processes and the equipment we manufacture
- Measure our carbon footprint and ensure the intensity of our footprint (impact per head or per \pounds of profit) does not increase over the long term
- Manage waste generated in our business operations, incorporating recycling, reusing and responsible disposal, to protect the environment and prevent pollution
- Continue to give consideration to the non-renewable energy consumption of our facilities during their design, build and any refurbishment activities
- As a minimum, comply with all environmental legislation
- Maintain ISO14001 accreditation through monitoring and review

4 How **3P** plans to meet our commitments

The measures below outline the actions 3P has taken and will continue to take in order to meet our environmental commitments

- Provide management oversight and review of environmental policies, procedures and performance, and the resources required for their effective direction and implementation
- Monitor key objectives and targets at least annually

- Monitor the environmental impacts of the business, in accordance with appendix 1 of the policy
